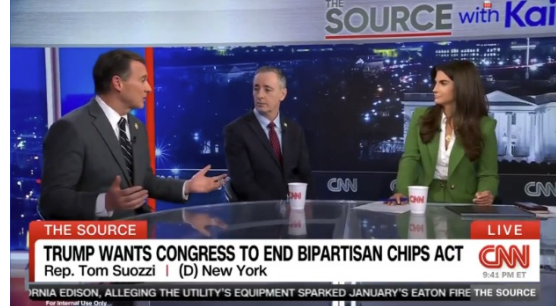

# PSC Member-Led Bipartisan Legislation

PSC Members have led 864 bipartisan bills so far this Congress. Here are a few to keep an eye on:

## [H.R. 835: 9/11 Memorial and Museum Act](#)

Introduced on January 31, 2025

Led by Representatives Nick LaLota, Tom Suozzi, Nicole Malliotakis, Josh Gottheimer, Mike Lawler, Susie Lee, Andrew Garbarino, Jen Kiggans, Brian Fitzpatrick, and Tom Kean, this bipartisan bill would provide a one-time grant to support the operation, security, and maintenance of the National September 11 Memorial & Museum. This legislation ensures the preservation of the memorial as a place of reflection and education for future generations to uphold the legacy of all affected.

## [H.R. 1826 & 1827: Child Care Availability and Affordability Act & Child Care Workforce Act:](#)

Introduced on March 4, 2025

Led by Representatives Salud Carbajal, Mike Lawler, and Juan Ciscomani, these bipartisan bills aim to make child care more affordable and accessible by strengthening existing tax credits to lower costs for families and take steps to increase the number of child care providers nationwide.

## [H.R. 2048: Metastatic Breast Cancer Access to Care Act](#)

Introduced on March 11, 2025

Led by Representatives Andrew Garbarino and Brian Fitzpatrick, this bipartisan bill would eliminate the waiting periods for federal disability insurance benefits and Medicare coverage for individuals undergoing treatment for metastatic breast cancer. This will ensure that patients receive critical care and financial support when they need it most.
